General Policy of Operation for use of Athletic Field Facilities

- 1. The Athletic Field facilities shall be available to any group in Gardena or vicinity for activities which contribute to the best recreational, social, cultural, civic, and educational interests of the citizens of Gardena.
- 2. Reservations for the use of Athletic Fields shall be granted with preference order as follows, and subject to change or cancellations at any time when facility is needed for Citysponsored functions:
 - A. City-Sponsored or Co-Sponsored
 - B. Parallel, School, Civic Groups
 - C. Private Groups
- 3. Use of Athletic Fields shall be granted under the following conditions:
 - A. Permanent rental or assignments of space on field shall not be made to any individual or organizations. This reservation will expire on date shown on reverse side. If a group wishes to continue to meet, a new Reservation Request must be submitted prior to the expiration date shown.
 - B. Alcoholic drinks (beer included) shall not be allowed on the premises.
 - C. All persons and groups must observe the limitations of their reservation, not disturbing or trespassing on the rights of others.
 - D. Officers of all groups shall be held responsible for the conduct of and any damage done by their members.
 - E. Due to limited storage space, all articles or property of individuals or groups shall be removed from the Athletic Field following their activity. The Recreation and Human Services Department assumes no liability for same if left on the premises.
 - F. Private groups shall be assessed a fee for use of fields on recreational facilities.
 - G. All youth groups using the Athletic Fields shall have adult leaders present during the entire function. Failure to provide adult chaperonage will result in relinquishing use of the field.
 - H. A charge will be made to all organizations, other than department sponsored or cosponsored groups who use recreational Athletic Fields for fund-raising purposes, or solicit donations to help defray costs of their activity.
